

**VALLEY VIEW GOLF COURSE
TOURNAMENT GROUP AGREEMENT**

THIS AGREEMENT IS MADE BETWEEN VALLEY VIEW GOLF COURSE AND

YOUR GROUP HAS REQUESTED THE DATE OF _____

STARTING AT _____AM/PM FOR _____ FOURSOMES AND ____ CARTS.

2011 FEE SCHEDULE (INC TAX PER PERSON):

MONDAY (AM SHOTGUN)	\$34.00 GREEN FEE & CART
TUESDAY-SUNDAY	\$42.00 GREEN FEE & CART

1. DAMAGE AND INDEMNITY: Your company or group agrees to hold harmless Davis County & Valley View G.C. from any and all injury to persons or damage to property and agrees to reimburse the facility and/or it's concessionaires for any and all damage caused by any person in or associated with your group.

2. DEPOSIT REQUIREMENTS: All tournament groups will be required to send in a nonrefundable deposit. This deposit will be applied toward your fees on your tournament date. Credit cards may be used instead of cash or check for your deposit, but a 3% fee will be added. Cancellation of your tournament will result in the forfeiture of your deposit.

3. PAYMENT OF FEES AND TEE TIME SCHEDULES: All green fees and cart fees must be prepaid by the Saturday prior to your tournament date. We will accept credit cards for your tournament fees, but a 3% fee will be added to your bill. The tournament director must provide a pairings schedule to the pro shop when paying for the tournament. Food service costs will be paid to the concessionaire on the day of play and must be paid by check or cash.

4. NO-SHOWS: No-shows will not be refunded. Foul weather refunds will be given if the course is closed due to weather conditions. Rained out tournaments will be rescheduled as the calendar permits.

5. FOOD AND BEVERAGE SERVICES: All food and beverage services must be provided by the food service concessionaire. You will not be allowed to dispense food or beverages of any kind to tournament participants or volunteers. Please contact the food concessionaire by calling 546-1630 to make food service arrangements. (See food service options at our website at: (www.valleyviewutah.com.) **the buy-out for the concessionaire in 2012 will be \$500.**

**PLEASE INFORM YOUR GOLFERS THAT IN ORDER TO COMPLY WITH UTAH
LIQUOR LAWS: PERSONAL COOLERS WILL NOT BE ALLOWED**

6. SPECIAL GOLF COURSE PREPARATION: Closest to the hole and long drive markers are available at no cost from the pro shop. If you need lines drawn for straight drive contests, sponsor signs put on tees, or any other special requirements for your tournament, please let us know and get us the necessary materials at least the day before your event. Groups must play the white tees unless given special permission.

7. PACE OF PLAY: Players will be expected to play in less than five hours.

8. NUMBER OF PLAYERS: The maximum number of players for a full shotgun is 140 (35 foursomes) Please do not exceed 140 players. If you have more than 140 players please contact Dave to discuss this.

9. TEE PRIZES & TOURNAMENT WINNINGS: Tournament groups will not be allowed to dispense golf products/tee prizes to their participants unless you have cleared it with the Tournament Staff. We can provide tee prizes, logo balls, hats, towels, gift certificates, etc. We will give the following certificate in addition to what you spend (\$100-\$500: additional-10% certificate, \$501-1,500: additional-15% certificate). Please allow us the opportunity to work with you in providing your tournament prize needs.

IF YOU PLAN ON GIVING AWAY ANY TEE PRIZES, OR TOURNAMENT PRIZES, YOU MUST MAKE ARRANGEMENTS WITH DAVE OR PRIOR TO YOUR TOURNAMENT DATE.

10. DRIVING RANGE: The price to include range balls for your tournament is \$1/person. The balls will be on the driving range tee.

11. CANCELLATION POLICY: Groups that cancel their tournament after it is calendared and their deposit is received will lose their deposit. Groups canceling within 7 days will lose their deposit and be billed full price for every tee time not filled during their scheduled tee times.

12. AGREEMENT: THIS DOCUMENT IS THE ENTIRE AGREEMENT BETWEEN _____ AND VALLEY VIEW GOLF COURSE. BY SIGNING THIS CONTRACT, GROUPS AGREE TO ABIDE BY THE RULES AND REGULATIONS ABOVE.
