## 2. FOOD AND BEVERAGE SERVICES

**In order for our food service concessionaire to comply with Utah Liquor Laws, all liquor must be purchased through their services. You will not be allowed to bring and dispense alcoholic beverages of any kind to your event. No outside coolers will be allowed.**

## 3. PAYMENT/REFUND POLICY

Payment is required no later than 3 days in advance. Groups that have not paid by this deadline will have their event cancelled and tee times opened up to the public.

\*No refunds or rainchecks available for shotgun tournament fees.\*

\*Refunds may be given for dangerous weather or severe flooding resulting in course closure.

## 4. TOURNAMENT PROCEDURES

Event dates are confirmed on the calendar when the Shotgun Tournament Agreement is received by the course. Tournament directors will receive a pairing sheet to organize their groups. The pairings must be submitted to Assistant Golf Professional Shane Scott 2 days prior to the event.

Starting holes will be set by the Golf Professional working with the Tournament Director

**Final tournament pairing revisions must be made 24 hours in advance. All requests made after 24 hours will not be granted and will be the responsibility of the tournament director**
